## Representative Matters

Tom has served as lead counsel or sole defense counsel in over 90 medical malpractice trials before juries in state and federal courts or before arbitration panels in Maryland, the District of Columbia, and Virginia. Representative trials have included the defense of brain-damaged baby cases involving allegations regarding the proper management of pre-natal and labor care, including the interpretation of fetal monitor tracings; a brain-damaged baby trial regarding an alleged failure to diagnose alloimmune thrombocytopenia; trials regarding the proper diagnosis and treatment of cancer, including lung cancer, small bowel cancer, nasopharyngeal cancer and cancer of the tongue; a personal injury claim by a 24-year-old quadriplegic who accused a neurosurgeon of improperly treating an arterial venous malformation in the brain; a wrongful death case alleging the failure to diagnose injury to the innominate artery in a 15-year-old boy; two trials involving injuries to the common bile duct following laparoscopic gallbladder surgery; three trials arising out of the suicides of psychiatric patients; and multiple cases alleging injury or death after falls in a healthcare facility.
